#### PRIVACY POLICY

We understand that you value how your information is used and shared, and we appreciate your trust in us to handle it responsibly. This Privacy Policy describes how Gati Express & Supply Chain Private Limited and its affiliates including Allcargo Gati Limited and Allcargo Supply Chain Private Limited (collectively "AllcargoGati, we, our, us") collect, use, share or otherwise process your personal data through AllcargoGati website https:www.gati.com, and / or its mobile application (hereinafter referred to as the "Website") and process your personal information through Website, services, products, features, and applications that reference this Privacy Policy (together "Services").
